SEC. 4. It is further ordained that no restrictions of the ^{Speed of locomotives within city limits.}
 speed of locomotives and trains to be run on said railroad
 through the city of Tucson shall be made requiring said
 locomotives and trains to be run at a less speed than ten miles
 an hour.

SEC. 5. Ordinance No 19, passed and adopted August 5, 1879,
 is hereby repealed.

ORDINANCE NO. 22.

OPENING AND ESTABLISHING TOOLE, AVENUE AND STEVENS
 AVENUE AS PUBLIC STREETS.

ORDINANCE NO. 23.

PROHIBITING THE KEEPING OF PLACES FOR SMOKING
 OPIUM.

The Common Council of Tucson do Ordain as follows:

SECTION 1. Any person or persons who shall keep a room,
 building, arbor, booth, shed or tenement to be used for the
 purpose of eating, smoking or inhaling of opium; or if the ^{Keepers and owners of buildings made liable.}
 owner, superintendent or agent of any room, building, arbor,
 booth, shed or tenement, or other premises, shall become
 aware that the same is used or occupied for the purpose of
 eating, smoking or inhaling opium, and shall within a
 reasonable time after having obtained such knowledge fail to
 report the same to the Mayor or City Marshal of the city of
 Tucson. he shall be deemed guilty of misdemeanor, and shall
 on conviction, be fined not less than fifty dollars, nor more
 than two hundred dollars, or imprisonment not exceeding

ninety days in the county jail, or both.

Attendance prohibited

SEC. 2. All persons are hereby prohibited from attending or being present in any room, arbor, shed, booth, or tenement, where the smoking, eating or inhaling of opium is being carried on, under a penalty, on conviction, of a fine not exceeding twenty-five dollars, or imprisonment in the county jail not exceeding sixty days, or both. This section shall not apply to the officers of the law in the discharge of their duty.

Witnesses for prosecution

SEC. 3. Every person duly summoned as a witness for the prosecution on any proceedings had under this Ordinance who neglects or refuses to attend as required, is guilty of a misdemeanor, and shall be punished by a fine not exceeding twenty-five dollars, or imprisonment in the county jail not exceeding sixty days.

Possession of apparatus as a misdemeanor

SEC. 4. If any person shall keep or exhibit any box, pipe, cup, thing or apparatus, or if any person shall act as a lookout or tender at any place where the eating, smoking or inhaling of opium is being practiced or carried on, he shall be deemed guilty of a misdemeanor, and shall, on conviction be punished by fine of twenty-five dollars, or imprisonment in county jail not exceeding sixty days, or both.

Seizure and destruction of apparatus

SEC. 5. It shall be the duty of the police of said city to seize and safely keep all cups, pipes, apparatus, boxes and things used for the purpose of eating, smoking or inhaling opium and produce the same in court, and to be retained until the final disposition of any case in which said articles may be required as evidence, to be then destroyed by order of the county; but nothing herein contained shall prevent the destruction of said articles at any time when the judge of said court may deem said articles no longer required to be retained as evidence.

Publication

SEC. 6. The Recorder of the city shall cause this Ordinance to be published in English in the Daily Star, and in Spanish in the La Sonora, newspapers in the city of Tucson, and thereupon it shall take effect and be in force twenty days after the publication thereof.
